Membership Requirements

Active Member (LIFE & ANNUAL) - To qualify as an Active member of the Society, the applicant should hold at least a B.D.S. degree from any University in India recognised by the Dental Council of India or M. D. S., D. N. B. (Implantology) or D. D. S. or any other equivalent Foreign qualification, and should produce documentary evidence that he / she has attended at least one training course in Oral Implantology in any system. All Active members shall have voting rights & only Active Life members shall be eligible to stand for election. If an Active member is a Director or Partner of a firm which is a Manufacturer, Supplier or Dealer in Dental Implants, Implant equipment, and / or Implant related materials he / she shall not be eligible to stand for election.

Associate Member: - Associate membership is open to Dental Surgeons, Dental Laboratory Technicians, Dental Hygienists, Manufacturer, Supplier or Dealer in Dental Implants, Implant equipment, and / or Implant related materials, Physicians, Surgeons & Research Personnel. Associate members shall not have any voting rights & shall not be eligible to stand for election. However, they may have a voice at the General Body Meetings. Associate members subsequently fulfilling the requirements of Active membership may apply to the Secretary to convert his / her membership to Active member by submitting the required documents.

Student Member: - Student Membership is open to undergraduate and postgraduate Dental Students, Dental Mechanic Students and Dental Hygienist Students. This membership is for one year only and can be renewed only as long as the person is a student. Student members shall not have any voting rights. However, they may have a voice at the General Body Meetings.

An Indian Active or Associate member may be either Life or Annual member. An Overseas Active Member can only be a Life Member.

All class of members shall abide by the Constitution. Any member may withdraw from the Society by a written notice to the Hon. Secretary or the President. The withdrawal of the membership would have to be confirmed by the approval of the Executive Council.

Annual membership fees are for the financial year April 01 to March 31 for Ordinary members & for the academic year July 01 to June 30 for Student Members; these fees are payable for the full year, irrespective of the month of joining.
